# EUSTORY Next Generation Summit 2024

# **General Remarks**

Before applying, please ensure that you will indeed be able to participate. Should the event interfere with your school, university or work schedules and you require assistance to obtain leave from school or university due to special reasons (e.g. an exam), please contact the EUSTORY Team (<u>eustory@koerber-stiftung.de</u>) to issue a request to the principal of your school or university.

### Costs

Participation in the Summit is mostly free of charge. The organiser will organise and cover the costs of food and accommodation in Riga from the beginning of the event on 23 October to the checkout on 27 October 2024 for all participants. Food consumed in leisure time is excluded from this regulation. The Summit Coordination Team will support you in the booking process and pay for your journey from an international airport / harbour/train/bus station in your proximity to the Summit location giving priority to the most ecofriendly connections. Thereby, we will ask those whose outward ticket to Riga costs less than 150 € to organise the outward journey themselves in consultation with the Summit Coordination Team and – if possible – to pay for it in advance. It will be fully reimbursed to the participant during or shortly after the event in Riga.

### Accommodation and Catering

Participants will be accommodated in two youth hostels in gender-separated dormitories with fellow Summit participants. For the whole event, safety and security are top priorities. Members of the Summit Team will be available 24/7, will supervise the minor participants during the day, some will stay with the group at night and will control the given curfews. There will be no security checks during the night.

## Visa

If you require a visa for Latvia, please contact the Summit Coordination Team via <u>eustory2024@labconcepts.de</u> as soon as possible so the visa application can be prepared. Körber-Stiftung will cover the costs of your visa.

#### Insurance

Körber-Stiftung will arrange and cover a medical travel insurance for all non-Latvian participants. Additionally, we recommend all participants to take out insurances like liability protection, casualty insurance, or theft insurance for their luggage individually.

#### **Participation of Minors**

The EUSTORY Next Generation Summit 2024 will be open for participants aged 16+. Applicants who are younger than 18 years old at the time of the event can only apply with the legal consent of a parent or legal guardian, given by the signed <u>«Declaration of Consent for the</u> <u>Participation of Minors»</u> which must be submitted online during the application process.

## No Legal Right to Participation

Unfortunately, it is not always possible to offer all applicants a participation. There is no legal right to participation. Even after an invitation has been issued, the workshop you applied for may be cancelled due to illness of staff or a force majeure. # Withdrawal from Participation

Pedagogical projects like the EUSTORY Summit are expensive and costs arise even when a participant withdraws. Therefore, the following rule applies: After having confirmed the invitation to the Summit, the candidate can reject to participate within one week. In case the withdrawal is announced at a later stage, the organisers will try to find a replacement. If nobody can be found, the organisers reserve the right to charge a cancellation fee of 100  $\in$ . This does not refer to cases of illness confirmed by a doctor's certificate.

### **Rules and Regulations**

We expect active participation and the completion of specific tasks during the respective workshop. Due to reasons of liability and with respect to minors, smoking and consuming alcohol are prohibited during the entire Summit. For reasons of liability and responsibility of the organisers, minors are only allowed to split from the main group in units of at least three people after consulting with the Summit Team and if the Declaration of Consent allows it. Minors are subject to a curfew after 11 p.m. Participants who disturb or boycott the programme or disregard the given instructions may be excluded from the Summit and may be charged with extra costs.

## Use of Material

Photos, audio recordings or videos taken of and/or by the participants during the EUSTORY Summit may be used for publication in all media e.g., on the internet, in videos and print media by the organisers (Körber-Stiftung, EUSTORY) or by their project partners. The participants agree to the publication of their work results for documentation purposes in print media, on radio, television, online or in the frameworks of public events hosted by the organisers or their project partners.
